# Ready, Set, Certify

If you've read our [Healthcare Certification 101 guide](#), you already know all of the reasons why it pays to be certified: access to major advertising platforms, more seamless payment processing, and improved patient trust.

Now, you're ready to take the step to get certified. But where to start? In this guide, we walk you through the application process step by step. You'll learn how to start an account, what our review entails, and what happens after you've become LegitScript-certified.

# 1. Application Process: Your Roadmap

1. **Create an account** in our client portal [certification.legitscript.com](https://certification.legitscript.com)
2. Pay the nonrefundable **application fee** before starting the questionnaire; additional annual certification fees are only due upon approval. See pricing on our [website](#).
3. Select the option for **expedited review** if you'd like to prioritize the start of your application's review.
4. Complete the **application questionnaire**; it can be saved and resumed at any time. As part of the questionnaire you will upload the documents outlined in the Healthcare Certification 101 guide. We recommend having those ready in advance.
5. Once you **submit your application**, it will be reviewed to ensure all required information and documents are complete.
6. **Clarify and remediate** your application, if necessary. Analysts may contact you for additional details or corrections; swift responses help to expedite the process.
7. Pay the **additional annual subscription fee** once you have been approved to finalize your certification.

## 2. What the Review Includes

During your review, analysts conduct a thorough evaluation of key aspects including licensure, business registration, website content, affiliates, privacy policies, patient practices (services, products), and promotional activity. They may have questions about the application or need additional documentation.

It's not uncommon for a business to have areas of minor noncompliance that must be remediated before receiving certification. We encourage applicants to respond promptly to questions to help keep their application review on track.

## 3. Common Analyst Requests and How to Avoid Them

It's important to submit a complete and thorough application to avoid delays in its review. Below are some of the most common issues that can hold up an application.

### Incomplete Documentation

Use checklists and upload relevant templates like the compounding addendum, healthcare licensure, telemedicine sheets. Check our [Healthcare Certification page](#) to download all of the resources you'll need to complete your application.

\*Note: **Every** applicant will need to complete the **Corporate Holdings** tab of the licensure spreadsheet.

### Unverified Partners

Your partners play a crucial part in your business, which means they're also an important part of your application review. A merchant's partners, such as partner pharmacies responsible for the fulfillment of prescription medication to patients, are generally required to be LegitScript-certified or accredited by another recognized body. Be sure to verify whether your partners hold a **Certified** or **Legitimate** status before submitting your application on our website using the [See the Status of a Website tool](#). Please be advised that there is a maximum of 5 free look-ups per week per IP address.

## Website Under Construction

We understand that your website may not have yet launched as you pursue certification. In these instances, we ask you to provide wireframes or snapshots of your website along with clear go-live timelines. We ask that you inform us when your website goes live so we can perform a final review; as an incomplete website will typically lead to a preliminary certification.

### About Preliminary Certification

Preliminary Certification is a temporary status **typically** granted to applicants who meet LegitScript's Certification Standards but have certain aspects of their business still in development, such as a website that has not yet launched. This designation allows applicants to demonstrate compliance in advance and transition seamlessly to full certification once all components are live.

Preliminary Certification offers the same benefits as regular certification, and your status will be publicly verifiable on LegitScript's website. However, the certification seal code will be issued only once the conditions of preliminary certification have been met.

## Inadequate Provider Transparency

Applicants' websites must clearly disclose all states, territories, provinces, and/or countries in which applicants' services are available. The applicant must also provide all domain names and websites under its control, and disclose all affiliates.

## Unclear Policies or SOPs

It's important that your business have clear written policies and standard operating procedures (SOPs) around processes such as quality assurance, batch testing reports, and compounding, where applicable. Please have this documentation ready.

## Undisclosed Disciplinary History

Please disclose any prior criminal, regulatory, or civil violations, along with any ongoing, resolved or otherwise addressed litigation, that involves the principals, key staff, and any medical or pharmacy practitioner associated with the business. Additionally, please describe remediation plans associated with any adverse history.

## 4. Post-Approval: What Comes Next

### Ongoing Monitoring

LegitScript performs ongoing monitoring throughout a healthcare merchant's certification period to ensure compliance. This ensures your business stays aligned with our Certification Standards across licensure, legality, patient safety, and promotional practices.

### Seal Usage

Certified healthcare providers are encouraged to display their custom LegitScript seal on their website, but they are not required to do so. The LegitScript seal code is customized for your certified website and links directly to your public verification page showing your current and active certification status, reinforcing trust and credibility.

## Handling Reports

We take reports of noncompliance seriously. If issues of noncompliance or violative activity surface after approval, LegitScript will require remediation. Failing to respond or correct violations could result in certification suspension or revocation of your certification.

## Certification Renewal: Keeping Your Certification Active

Compliance is not about providing a snapshot in time, but demonstrating an ongoing and persistent commitment to proper business practices. This is why LegitScript requires annual renewals and performs ongoing monitoring.

Certification is valid for one year from the date of certification. However, your certification will remain continuous as long as your renewal is completed in a timely manner.

You'll be notified by LegitScript when it's time to renew — typically 60 days before your certification expires. If your business has had changes in the past year, e.g. new owners, licenses, websites, products, or services, we'll ask that you provide updates in your renewal questionnaire. The renewal process is usually faster than the initial application, provided your business has maintained good standing and submitted timely updates. It's completed once payment has been submitted for your annual certification fee, which is automatic on your renewal date, and you've notified us of any applicable updates.

## Advertising Compliance: Your Certification Is Not a Free Pass

One of the most valuable benefits to LegitScript Healthcare Merchant Certification is that it unlocks advertising eligibility on platforms including Google, Meta (Facebook/Instagram), Microsoft (Bing), TikTok, and others.

However, each platform has its own advertising policies to which you must still comply. Noteworthy examples of these policies include:

- **Claims requirements:** ensuring your ads refrain from making prohibited disease/health claims or structure/function claims
- **Prohibited content rules:** refraining from advertising products or services prohibited by the platform
- **Landing page standards:** ensuring the pages your ads link to adhere to the policies of the platform

While LegitScript Certification opens the door to advertising on these platforms, it does not shield your ads from rejection or from account penalties if your ads violate platform rules. Be sure to read and understand the policies of each platform before advertising.

## 5. Ongoing Best Practices

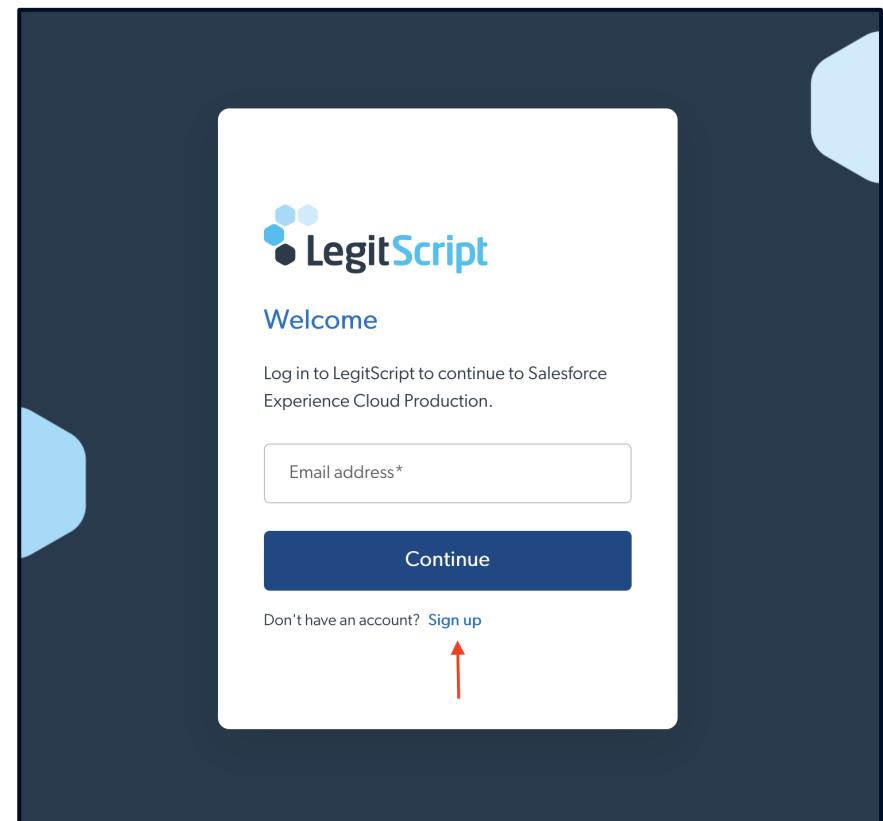
LegitScript wants to support you in maintaining ongoing compliance so that you can avoid disruption to your ad campaigns and potential problems with your payment processing. Following are some tips to ensure your business remains compliant.

1. **Regularly audit.** Now that you are familiar with LegitScript's Certification Standards, periodically review your website, documentation, and business practices to ensure they continue to conform.
2. **Licensure and registration.** Ensure all healthcare provider, pharmacy, or business licenses remain valid and current in all jurisdictions where you operate.
3. **Staff changes.** Inform LegitScript if any staff, especially those involved in prescribing or dispensing, products, services, licensure, areas of operation, etc., change. Additionally, certified entities are required to notify LegitScript within 30 days after becoming aware of any staff that is subject to disciplinary action.
4. **Domain ownership and website content.** Ensure your website clearly displays required information and scrutinize any changes to website content to ensure it adheres to Certification Standards.
5. **Affiliates and partners.** Monitor relationships with partner pharmacies, telemedicine providers, and distributors to ensure they remain in compliance. Inform LegitScript of any changes to your affiliates or partners.
6. **Advertising copy.** Avoid using unapproved health claims or misleading descriptions.
7. **Be responsive.** If LegitScript contacts your team with any post-certification inquiries, respond quickly and completely. Failure to engage could jeopardize your certification status and downstream partnerships.

Certification fees will be charged on a recurring basis, billed annually on the anniversary of the certification date. Certification can be canceled at any time by logging into your account, where you can click on your renewing certification in the lower half of your screen. Select Update Certification at the top-right corner. Then, click Cancel Certification and follow the prompts to complete the cancellation process.


