Licensure and Registration

- ☐ Please be sure to include your active Secretary of State filing number on the Business Registration tab of the [LegitScript licensure template](#).
- ☐ Be prepared to provide license information for all licensed professionals providing services to your patients, including Doctors (MD, DO), Nurse Practitioners, Physician Assistants, Nurses, and any other licensed medical professional serving patients.
- ☐ If you are domiciled in or serving a jurisdiction that requires a Medical Spa-specific license, please be ready to provide this information.
- ☐ Prescribing/dispensing controlled substances? Please upload a copy of your DEA Certificate(s).
- ☐ If you are participating in physician dispensing, please be sure to include the name and applicable license information for the entity from which you are sourcing medications. Additionally, please be ready to provide any licensure that may be required in your jurisdiction(s) for participating in physician dispensing.

Legal Compliance

- ☐ Please ensure all advertising claims and marketing content are supported by medical research, are transparent, and are in line with current FDA guidelines.
 - ☐ Common offerings with more stringent advertising guidelines include, but are not limited to, claims related to NAD+, hyperbaric oxygen therapy, and advertising hormone replacement therapy for increased muscle mass.
- ☐ Subject to discipline within the last 10 years? Please have evidence/documentation to support discipline resolutions. Please reference our [Terms & Conditions - IV\(d.\)](#) for examples of Disciplinary Action.
 - ☐ Please be aware that while an FDA Form 483 and/or inspection report are not considered to be disciplinary action, this information must be provided if your business has received these forms where observations were made by regulatory bodies that required corrective action.
- ☐ Ensure your website features a U.S. HIPAA-compliant (or country-specific) privacy policy, or have one ready for our review if you do not have an online presence.
- ☐ Does your business utilize standing orders for any patient services? If so, please be prepared to demonstrate how this practice is compliant in the jurisdiction(s) you serve.
- ☐ If you are providing mobile services, please be prepared to provide information on how these services are compliant in the jurisdiction(s) you serve.
- ☐ If you provide telehealth services, please fill out all applicable information within our telemedicine [template](#).

Patient Services

- ☐ Have you ensured that your products and services are up-to-date with regulatory requirements, and that you are not offering prohibited services or impermissible products?
 - ☐ Common barriers to certification include, but are not limited to, offering steroids for bodybuilding purposes, hCG for weight loss, stem cell/exosome therapy, and ozone therapy.
- ☐ Are you offering any compounded products or services? If so, please be prepared to demonstrate compliance with such products/offerings.

Transparency

- ☐ When uploading an image of your domain's Whois information, please be sure the contact information depicted is transparent and accurate.
 - ☐ Please be sure that the screenshot you provide from your domain's registrar displays the following Whois information (that is not privacy-protected): registrant name, registrant

organization (if applicable), registrant address, registrant phone number, and registrant email address.

- ☐ Are patients receiving medications in the mail? Please be sure your website displays the name, address, and phone number of the dispensing pharmacy.
- ☐ Is your website still under development or expecting updates? Please prepare wireframes or screenshots for our review and inform us of the expected timeline for completion.

Affiliates

- ☐ Ensure that all affiliates or affiliations with your business are compliant and operating legally.
 - ☐ Affiliates are any individual, business, or entity who previously, currently, or is expected to have a commercial and/or professional relationship with the applicant organization or its principal(s).
 - ☐ Common barriers include, but are not limited to: affiliations with the sale of ingestible CBD products, the sale of unapproved drugs (for example: impermissible peptides or bulk drug substances), or affiliates with severe disciplinary history.
- ☐ Remember that [applicable business models](#) utilized/promoted on the submitted domain must also be certified, per our [Terms & Conditions - VI\(d.\)](#).

Partner Pharmacy Requirements

- ☐ Did you know that all partner pharmacies are required to be certified through LegitScript or be NABP-accredited?
 - ☐ A partner pharmacy is defined as a pharmacy utilized by an applying entity to fulfill and/or dispense prescription medication orders to/for patients of the applying entity.
- ☐ Have you searched for and verified your partner pharmacy's LegitScript Certification status [here](#)? Is your partner pharmacy LegitScript certified?
 - ☐ If yes, great! Please be ready to have the pharmacy representative email us to confirm your affiliation.
 - ☐ If not, please confirm they are ready and willing to apply for their own certification.
- ☐ Do you offer IV infusion and/or IV vitamin therapy? Please be sure to provide us with the name(s) of all pharmacies that compound and/or supply these offerings.
