## How it Works

- Complete your initial application at [legitscript.com/gpr-apply](https://legitscript.com/gpr-apply).
- Complete and submit your **spreadsheet of products** (sent to you after you submit your initial questionnaire).
- The LegitScript team will review your application and products for eligibility, and then invoice you to pay the **application fee** and **product review fee** based on the number of eligible products.
